

RESOLUTION NO. 23-01

A RESOLUTION CALLING FOR AN ELECTION AND PROVIDING PROCEDURES FOR CANDIDATES TO FILE FOR ELECTION TO BE HELD BY THE CITY OF SILSBEE, TEXAS ON MAY 6, 2023 FOR THE PURPOSE OF ELECTING THE FOLLOWING: COUNCIL MEMBER AT LARGE, PLACE I (1 YEAR UNEXPIRED TERM), COUNCIL MEMBER AT-LARGE, PLACE II, COUNCIL MEMBER DISTRICT C, COUNCIL MEMBER DISTRICT D, AND A MAYOR AND PROVIDING FOR PLACE AND MANNER OF HOLDING SAID ELECTION.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SILSBEE.

Section 1. An election shall be held on Saturday, May 6, 2023, at which the qualified voters of the City of Silsbee, Texas, shall elect a Mayor and four (4) Council Members as follows: One (1) At-Large Council Member, Place I (1 year unexpired term), One (1) Council Member, Place II, One (1) Council Member for each of the following single-member districts: District C and District D; all as provided in Section 3.01, Charter of the City of Silsbee, Texas, as amended. The Mayor, Council Member At Large, Place I, Council Member At-Large, Place II, Council Member District C, and Council Member District D, shall be elected by a majority of the qualified voters at such election, and shall serve a term of two years, or until the unexpired term of the former Council Member which shall end in May 2023 or until his or her successor has been qualified.

Section 2. The election precincts for this election shall be and are hereby established as follows: District A shall vote on Council Member At-Large, Place I, Council Member At-Large, Place II, and Mayor; District B shall vote on Council Member At-Large, Place I, Council Member At-Large Place II, and Mayor; District C shall vote on Council Member District C, Council Member At-Large, Place I, Council Member At-Large Place II, and Mayor. Council Member District D shall vote on Council Member District D, Council Member At-Large, Place I, Council Member At-Large Place II, and Mayor.

Section 3. Said election shall be held from the hours of 7:00 o'clock a.m., until 7:00 o'clock p.m., on said date. Qualified voters shall vote at Silsbee City Hall, 1220 Hwy 327 East, Silsbee, Texas.


Section 4. Early voting shall be conducted at City Hall, 1220 Hwy 327 East, Silsbee, Texas, during the hours of 7:00 a.m. to 7:00 p.m. on the 24th day of April 2023, through the 25th day of April 2023, and then from 8:00 a.m. to 5:00 p.m. on the 26th day of April and ending on the 28th day of April 2023, and then from 8:00 a.m. to 5:00 p.m. starting on the 1st day of May 2023 and ending on the 2nd day of May 2023.

Section 5. Any eligible and qualified person may have his/her name printed upon the official ballot as a candidate for one of the following offices: Council Member At-Large, Place I (1 year unexpired term), Council Member At-Large, Place II, Council Member District C, Council Member District D, and Mayor by filing his or her sworn application during the hours of 8:00 a.m. to 5:00 p.m. at City Hall, 1220 Hwy 327 East Street, Silsbee, Texas, from January 18, 2023 through February 17, 2023. The application shall state the specific office being sought by the applicant and that the applicant is eligible and qualified under the laws of the State of Texas and Charter of the City of Silsbee, Texas, to become a candidate for and hold the office being sought, if elected.

Section 6. Said election shall be conducted in accordance with the Election Code of the State of Texas and the Charter and Ordinances of the City of Silsbee, Texas.
